

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.43% to settle the year to date return of the market at (-7.51%).

The Index closed at 24,826.75 basis point against the previous close of 24,933.41 basis point while Market Capitalization closed at 12,951,132,735,175.10 against previous close of 13,006,772,961,102.70. Volume traded increased by 2.03% from 171,208,471 to 174,676,912 while the total value of stocks traded decreased by 9.06% from 2,210,693,302.89 to 2,010,416,520.32 in 3,695 deals compared to 3,315 deals traded previously.

CUTIX, UNITYBNK, CHAMS, ABCTRANS and BUACEMENT top the gainers table by gaining 10.00%, 9.62%, 8.70%, 8.51% and 6.28% while UPL, NEIMETH, TRIPPLEG, STERLNBANK and CAVERTON top the losers table by shedding 10.00%, 9.94%, 8.62%, 7.69% and 6.98%.
