

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.38% to settle the year to date return of the market at (-8.15%).

The Index closed at 24,655.05 basis point against the previous close of 24,750.06 basis point while Market Capitalization closed at 12,861,532,711,935.00 against previous close of 12,911,127,795,274.70. Volume traded increased by 12.68% from 167,949,144 to 189,253,004 while the total value of stocks traded increased by 23.82% from 1,548,187,730.30 to 1,917,004,309.99 in 3,364 deals compared to 3,784 deals traded previously.
