## Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.12% to settle the year to date return of the market at (-8.26%).

The Index closed at 24,625.24 basis point against the previous close of 24,655.05 basis point while Market Capitalization closed at 12,845,979,297,808.40 against previous close of 12,861,532,711,935.00. Volume traded decreased by 31.16% from 189,253,004 to 130,279,680 while the total value of stocks traded decreased by 15.24% from 1,917,004,309.99 to 1,624,935,192.66 in 3,413 deals compared to 3,364 deals traded previously.

NEIMETH, WEMABANK, CHAMS, MAYBAKER and ETI top the gainers table by gaining 9.65%, 9.09%, 4.35%, 3.09% and 2.13% while LINKASSURE, JAPAULOIL, LIVESTOCK, ZENITHBANK and TRANSCORP top the losers table by shedding 9.43%, 7.69%, 2.86%, 1.52% and 1.43%.
