Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.83% to settle the year to date return of the market at (-7.50%).

The Index closed at 24,828.96 basis point against the previous close of 24,625.24 basis point while Market Capitalization closed at 12,952,286,110,017.90 against previous close of 12,845,979,297,808.40. Volume traded decreased by 2.36% from 130,279,680 to 127,204,531 while the total value of stocks traded increased by 32.55% from 1,624,935,192.66 to 2,153,829,222.25 in 2,844 deals compared to 3,413 deals traded previously.

AIRTELAFRI, ABCTRANS, NEIMETH, ETI and UACN top the gainers table by gaining 9.97%, 9.80%, 9.60%, 9.38% and 6.43% while FIDSON, UNITYBNK, CHAMS, PZ and REGALINS top the losers table by shedding 9.70%, 8.62%, 8.33%, 4.94% and 4.76%.
