Dear Esteemed Investor.

The Nigerian equity market close on a negative note today as the All Share Index (ASI) lost 1.53% to settle the year to date return of the market at (-8.80%).

The Index closed at 24,479.22 basis point against the previous close of 24,858.89 basis point while Market Capitalization closed at 12,769,811,217,754.10 against previous close of 12,967,865,182,215.30. Volume traded increased by 76.83% from 158,719,415 to 280,667,420 while the total value of stocks traded increased by 91.89% from 1,635,598,021.63 to 3,138,508,253.04 in 4,464 deals compared to 3,940 deals traded previously.
