

Dear Esteemed Investor,

The Nigerian equity market close on a positive note today as the All Share Index (ASI) gained 0.47% to settle the year to date return of the market at (-8.37%).

The Index closed at 24,595.05 basis point against the previous close of 24,479.22 basis point while Market Capitalization closed at 12,830,232,663,881.80 against previous close of 12,769,811,217,754.10. Volume traded decreased by 29.45% from 280,667,420 to 198,011,937 while the total value of stocks traded decreased by 66.98% from 3,138,508,253.04 to 1,036,449,725.80 in 3,772 deals compared to 4,464 deals traded previously.
