## Dear Esteemed Investor.

The Nigerian equity market close on a negative note today as the All Share Index (ASI) lost 0.93% to settle the year to date return of the market at (-10.18%).

The Index closed at 24,109.65 basis point against the previous close of 24,336.12 basis point while Market Capitalization closed at 12,577,018,783,433.00 against previous close of 12,695,157,128,674.50. Volume traded increased by 31.44% from 144,312,140 to 189,691,053 while the total value of stocks traded increased by 82.91% from 1,522,502,244.35 to 2,784,783,904.01 in 4,216 deals compared to 3,993 deals traded previously.
