Dear Esteemed Investor,

The Nigerian equity market close on a positive note today as the All Share Index (ASI) gained 0.30% to settle the year to date return of the market at (-10.22%).

The Index closed at 24,097.48 basis point against the previous close of 24,026.05 basis point while Market Capitalization closed at 12,570,673,213,060.70 against previous close of 12,533,410,160,572.70. Volume traded increased by 31.44% from 189,691,053 to 155,529,293 while the total value of stocks traded increased by 82.91% from 2,784,783,904.01 to 2,600,805,915.79 in 4,060 deals compared to 4,216 deals traded previously.

REDSTAREX, WAPIC, CILEASING, PZ and MBENEFIT top the gainers table by gaining 9.76%, 6.06%, 5.26%, 5.00% and 4.76% while OKOMUOIL, MRS, UNILEVER, MANSARD and CUSTODIAN top the losers table by shedding 9.95%, 9.78%, 9.78%, 9.66% and 9.09%.
