Dear Esteemed Investor.

The Nigerian equity market close on a positive note today as the All Share Index (ASI) gained 0.75% to settle the year to date return of the market at (-9.55%).

The Index closed at 24,278.07 basis point against the previous close of 24,097.48 basis point while Market Capitalization closed at 12,664,878,592,218.90 against previous close of 12,570,673,213,060.70. Volume traded increased by 49.56% from 155,529,293 to 232,609,049 while the total value of stocks traded increased by 80.65% from 2,600,805,915.79 to 4,698,272,125.17 in 3,523 deals compared to 4,060 deals traded previously.

WAPCO, JBERGER, LINKASSURE, REGALINS and REDSTAREX top the gainers table by gaining 10.00%, 9.90%, 9.30%, 9.09% and 8.90% while BERGER, CAVERTON, ETI, FLOURMILL and OANDO top the losers table by shedding 9.63%, 4.40%, 4.17%, 2.70% and 2.17%.
