Dear Esteemed Investor.

The Nigerian equity market close on a negative note today as the All Share Index (ASI) lost 0.44% to settle the year to date return of the market at (-9.84%).

The Index closed at 24,200.60 basis point against the previous close of 24,306.36 basis point while Market Capitalization closed at 12,624,464,581,540.30 against previous close of 12,679,634,946,216.90. Volume traded increased by 75.67% from 131,630,651 to 231,234,804 while the total value of stocks traded increased by 139.55% from 899,490,969.04 to 2,154,759,061.89 in 3,950 deals compared to 3,044 deals traded previously.

NPFMCRFBK, NEIMETH, LINKASSURE, ABCTRANS and CAVERTON top the gainers table by gaining 10.00%, 9.35%, 8.51%, 7.84% and 7.73% while MOBIL, CHAMS, ETERNA, WAPIC and TRANSCORP top the losers table by shedding 9.97%, 8.33%, 6.70%, 5.71% and 4.62%.
