

Dear Esteemed Investor,

The Nigerian equity market close on a positive note today as the All Share Index (ASI) gained 0.06% to settle the year to date return of the market at (-10.10%).

The Index closed at 24,130.26 basis point against the previous close of 24,114.59 basis point while Market Capitalization closed at 12,587,772,865,387.00 against previous close of 12,579,594,609,545.20. Volume traded increased by 0.003% from 208,203,183 to 208,209,536 while the total value of stocks traded increased by 66.37% from 1,058,925,735.05 to 1,761,737,867.93 in 3,648 deals compared to 4,174 deals traded previously.

SUNUASSUR, CUTIX, DANGSUGAR, MBENEFIT and AIRTELAFRI top the gainers table by gaining 10.00%, 7.69%, 5.17%, 4.76% and 3.44% while JBERGER, NB, LINKASSURE, WAPIC and CAVERTON top the losers table by shedding 9.88%, 9.84%, 9.80%, 9.09% and 6.15%.
