## Dear Esteemed Investor.

The Nigerian equity market close on a negative note today as the All Share Index (ASI) lost 0.17% to settle the year to date return of the market at (-9.52%).

The Index closed at 24,287.66 basis point against the previous close of 24,330.06 basis point while Market Capitalization closed at 12,669,877,915,818.90 against previous close of 12,691,995,738,189.40. Volume traded decreased by 22.61% from 207,400,280 to 160,501,175 while the total value of stocks traded increased by 49.08% from 987,769,065.30 to 1,472,571,829.19 in 2,997 deals compared to 3,323 deals traded previously.

GLAXOSMITH, ARDOVA, CHAMS, NAHCO and CAVERTON top the gainers table by gaining 9.20%, 7.73%, 4.55%, 4.04% and 3.83% while LINKASSURE, JAPAULOIL, REGALINS, TRANSCORP and NEM top the losers table by shedding 9.09%, 8.33%, 4.35%, 3.23% and 2.91%.
