

Dear Esteemed Investor,

The Nigerian equity market close on a negative note today as the All Share Index (ASI) lost 0.39% to settle the year to date return of the market at (-9.94%).

The Index closed at 24,174.45 basis point against the previous close of 24,269.58 basis point while Market Capitalization closed at 12,610,820,155,204.70 against previous close of 12,660,450,297,282.40. Volume traded decreased by 0.30% from 305,103,325 to 304,185,443 while the total value of stocks traded increased by 55.62% from 2,100,198,655.28 to 3,268,374,119.43 in 3,500 deals compared to 3,258 deals traded previously.

LINKASSURE, VITAFOAM, ROYALEX, UNITYBNK and TRANSCORP top the gainers table by gaining 8.57%, 7.88%, 7.41%, 6.12% and 4.84% while ETERNA, PRESTIGE, INTBREW, CORNERST and CAP top the losers table by shedding 10.00%, 9.26%, 9.21%, 9.09% and 8.23%.
