The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.34% to settle the year to date return of the market at (-8.99%).

The Index closed at 24,427.73 basis point against the previous close of 24,512.27 basis point while Market Capitalization closed at 12,742,950,223,566.90 against previous close of 12,787,048,277,096.40. Volume traded increased by 6.03% from 164,289,152 to 174,199,020 while the total value of stocks traded increased by 12.17% from 2,125,954,871.90 to 2,384,725,703.81 in 3,723 deals compared to 2,986 deals traded previously.
