## Dear Esteemed Investor.

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.54% to settle the year to date return of the market at (-8.17%).

The Index closed at 24,650.16 basis point against the previous close of 24,783.61 basis point while Market Capitalization closed at 12,858,982,827,133.20 against previous close of 12,928,597,764,196.50. Volume traded decreased by 11.53% from 169,998,011 to 150,398,795 while the total value of stocks traded decreased by 17.08% from 2,385,453,653.35 to 1,977,994,771.20 in 3,780 deals compared to 4,336 deals traded previously.
