

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.29% to settle the year to date return of the market at (-7.73%).

The Index closed at 24,766.12 basis point against the previous close of 24,693.73 basis point while Market Capitalization closed at 12,919,472,934,025.60 against previous close of 12,881,709,459,280.50. Volume traded increased by 83.57% from 101,586,874 to 186,481,739 while the total value of stocks traded increased by 34.52% from 973,636,783.16 to 1,309,755,694.10 in 4,718 deals compared to 3,685 deals traded previously.

NEIMETH, FLOURMILL, UPL, GLAXOSMITH and HONYFLOUR top the gainers table by gaining 10.00%, 9.97%, 9.90%, 8.16% and 5.00% while UACN, AIICO, SUNUASSUR, MBENEFIT and CUSTODIAN top the losers table by shedding 10.00%, 9.57%, 9.09%, 8.70% and 7.27%.
