

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.31% to settle the year to date return of the market at (-7.45%).

The Index closed at 24,841.94 basis point against the previous close of 24,766.12 basis point while Market Capitalization closed at 12,959,024,699,151.90 against previous close of 12,919,472,934,025.60. Volume traded decreased by 17.17% from 186,481,739 to 154,467,244 while the total value of stocks traded increased by 11.28% from 1,309,755,694.10 to 1,457,531,880.26 in 4,222 deals compared to 4,718 deals traded previously.

MANSARD, UACN, JAIZBANK, NPFMCRFBK and MBENEFIT top the gainers table by gaining 9.72%, 8.73%, 7.27%, 5.88% and 4.76% while CAP, TOTAL, ARDOVA, UNILEVER and GLAXOSMITH top the losers table by shedding 9.94%, 9.91%, 9.67%, 8.57% and 8.49%.
