Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.16% to settle the year to date return of the market at (-7.30%).

The Index closed at 24,882.04 basis point against the previous close of 24,841.94 basis point while Market Capitalization closed at 12,979,941,721,993.50 against previous close of 12,959,024,699,151.90. Volume traded increased by 148.14% from 154,467,244 to 383,289,488 while the total value of stocks traded increased by 167.07% from 1,457,531,880.26 to 3,892,572,515.51 in 3,860 deals compared to 4,222 deals traded previously.

CAP, UAC-PROP, GLAXOSMITH, NEIMETH and TRANSCORP top the gainers table by gaining 9.74%, 9.52%, 6.19%, 5.42% and 5.08% while ETERNA, LIVESTOCK, MBENEFIT, LASACO and MAYBAKER top the losers table by shedding 9.00%, 4.62%, 4.55%, 4.00% and 3.33%.
