## Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 1.04% to settle the year to date return of the market at (-6.34%).

The Index closed at 25,141.48 basis point against the previous close of 24,883.70 basis point while Market Capitalization closed at 13,115,282,177,305.00 against previous close of 12,980,809,405,622.80. Volume traded decreased by 0.84% from 206,609,577 to 204,878,098 while the total value of stocks traded increased by 54.75% from 2,475,184,309.14 to 3,830,335,679.62 in 3,636 deals compared to 3,925 deals traded previously.

SEPLAT, CADBURY, AIRTELAFRI, PRESTIGE and NEIMETH top the gainers table by gaining 10.00%, 9.93%, 9.20%, 8.89% and 8.11% while CHAMPION, CHIPLC, MBENEFIT, SUNUASSUR and ACCESS top the losers table by shedding 9.30%, 8.11%, 4.76%, 4.76% and 2.29%.
