Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.02% to settle the year to date return of the market at (-6.35%).

The Index closed at 25,136.49 basis point against the previous close of 25,132.67 basis point while Market Capitalization closed at 13,112,743,202,052.90 against previous close of 13,110,751,847,971.40. Volume traded increased by 68.08% from 161,231,804 to 271,001,986 while the total value of stocks traded increased by 33.30% from 1,845,860,367.05 to 2,460,550,779.25 in 3,693 deals compared to 3,597 deals traded previously.

UPL, CORNERST, LASACO, UCAP and STERLNBANK top the gainers table by gaining 9.91%, 9.43%, 7.14%, 3.23% and 2.61% while CONOIL, ARDOVA, OANDO, FIDSON and JAPAULOIL top the losers table by shedding 9.76%, 9.68%, 9.68%, 5.25% and 4.76%.
