Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.14% to settle the year to date return of the market at (-6.22%).

The Index closed at 25,171.32 basis point against the previous close of 25,136.49 basis point while Market Capitalization closed at 13,130,941,199,485.60 against previous close of 13,112,743,202,052.90. Volume traded decreased by 33.58% from 271,001,986 to 180,010,447 while the total value of stocks traded decreased by 37.56% from 2,460,550,779.25 to 1,536,323,055.52 in 3,108 deals compared to 3,693 deals traded previously.

STUDPRESS, INTBREW, JAIZBANK, JAPAULOIL and MBENEFIT top the gainers table by gaining 10.00%, 7.14%, 5.36%, 5.00% and 5.00% while CAP, ROYALEX, PZ, UPL and GLAXOSMITH top the losers table by shedding 10.00%, 9.68%, 9.41%, 7.38% and 6.73%.
