Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.07% to settle the year to date return of the market at (-6.04%).

The Index closed at 25,221.87 basis point against the previous close of 25,204.60 basis point while Market Capitalization closed at 13,158,013,958,301.50 against previous close of 13,149,003,322,966.70. Volume traded decreased by 11.66% from 179,549,093 to 158,620,959 while the total value of stocks traded decreased by 30.56% from 2,526,062,664.76 to 1,754,131,492.65 in 3,194 deals compared to 3,055 deals traded previously.

LASACO, CHAMPION, UPL, INTBREW and UAC-PROP top the gainers table by gaining 10.00%, 9.86%, 9.73%, 9.09% and 6.98% while ABCTRANS, UACN, UNITYBNK, OKOMUOIL and FIDELITYBK top the losers table by shedding 6.98%, 5.98%, 3.70%, 1.25% and 1.10%.
