

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.03% to settle the year to date return of the market at (-6.01%).

The Index closed at 25,229.12 basis point against the previous close of 25,221.87 basis point while Market Capitalization closed at 13,161,793,393,414.10 against previous close of 13,158,013,958,301.50. Volume traded increased by 58.36% from 158,620,959 to 251,188,123 while the total value of stocks traded increased by 34.56% from 1,754,131,492.65 to 2,360,422,200.49 in 3,737 deals compared to 3,194 deals traded previously.

UPL, UNITYBNK, REGALINS, CHAMPION and CORNERST top the gainers table by gaining 9.68%, 9.62%, 9.09%, 8.97% and 8.62% while TRANSCORP, ROYALEX, JAIZBANK, NPFMCRFBK and PRESCO top the losers table by shedding 8.20%, 7.69%, 5.00%, 4.69% and 3.92%.
