Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.25% to settle the year to date return of the market at (-5.78%).

The Index closed at 25,291.73 basis point against the previous close of 25,229.12 basis point while Market Capitalization closed at 13,194,459,194,852.10 against previous close of 13,161,793,393,414.10. Volume traded increased by 0.06% from 251,188,123 to 251,339,756 while the total value of stocks traded decreased by 50.50% from 2,360,422,200.49 to 1,168,425,066.40 in 3,713 deals compared to 3,737 deals traded previously.

NEM, WAPIC, JAPAULOIL, JAIZBANK and JBERGER top the gainers table by gaining 9.63%, 6.25%, 4.76%, 3.51% and 3.03% while BETAGLAS, MAYBAKER, ARBICO, CILEASING and CUTIX top the losers table by shedding 9.99%, 9.90%, 9.52%, 9.09% and 7.89%.
