Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.15% to settle the year to date return of the market at (-5.63%).

The Index closed at 25,330.10 basis point against the previous close of 25,291.73 basis point while Market Capitalization closed at 13,214,475,455,081.90 against previous close of 13,194,459,194,852.10. Volume traded decreased by 28.09% from 251,339,756 to 180,732,619 while the total value of stocks traded increased by 15.98% from 1,168,425,066.40 to 1,355,133,591.52 in 3,411 deals compared to 3,713 deals traded previously.

FTNCOCOA, NNFM, UPL, CHAMPION and UACN top the gainers table by gaining 10.00%, 9.76%, 9.56%, 7.06% and 6.48% while CORNERST, AFRIPRUD, WAPIC, LEARNAFRCA and CUSTODIAN top the losers table by shedding 9.68%, 6.67%, 2.94%, 2.73% and 2.04%.
