

Dear Esteemed Investor,

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.10% to settle the year to date return of the market at (-5.73%).

The Index closed at 25,304.25 basis point against the previous close of 25,330.10 basis point while Market Capitalization closed at 13,200,991,388,000.30 against previous close of 13,214,475,455,081.90. Volume traded increased by 39.04% from 180,732,619 to 251,295,735 while the total value of stocks traded increased by 16.53% from 1,355,133,591.52 to 1,579,180,913.10 in 2,954 deals compared to 3,411 deals traded previously.

MAYBAKER, UPL, MANSARD, JAIZBANK and NB top the gainers table by gaining 9.89%, 9.40%, 6.36%, 5.00% and 2.78% while CHIPLC, FIDSON, LASACO, LIVESTOCK and CHAMS top the losers table by shedding 8.11%, 7.25%, 6.06%, 4.76% and 4.55%.
