

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.07% to settle the year to date return of the market at (-5.64%).

The Index closed at 25,327.13 basis point against the previous close of 25,309.37 basis point while Market Capitalization closed at 13,212,924,969,239.20 against previous close of 13,203,662,423,103.30. Volume traded increased by 120.36% from 137,054,655 to 302,009,486 while the total value of stocks traded increased by 185.46% from 920,526,930.40 to 2,627,756,087.96 in 3,854 deals compared to 2,869 deals traded previously.
