Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.34% to settle the year to date return of the market at (-5.32%).

The Index closed at 25,413.95 basis point against the previous close of 25,327.13 basis point while Market Capitalization closed at 13,258,220,499,237.50 against previous close of 13,212,924,969,239.20. Volume traded increased by 255.56% from 302,009,486 to 1,073,834,245 while the total value of stocks traded decreased by 19.91% from 2,627,756,087.96 to 2,104,566,958.75 in 3,221 deals compared to 3,854 deals traded previously.

LIVESTOCK, ETERNA, JAIZBANK, UAC-PROP and NEIMETH top the gainers table by gaining 10.00%, 9.47%, 8.93%, 8.24% and 7.53% while WAPIC, UBN, PZ, MAYBAKER and FCMB top the losers table by shedding 5.71%, 5.66%, 2.38%, 2.33% and 2.27%.
