Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.20% to settle the year to date return of the market at (-4.96%).

The Index closed at 25,511.02 basis point against the previous close of 25,460.00 basis point while Market Capitalization closed at 13,308,734,163,750.60 against previous close of 13,282,112,901,062.40. Volume traded increased by 28.18% from 181,320,844 to 232,416,080 while the total value of stocks traded increased by 17.27% from 1,121,578,171.01 to 1,315,221,250.27 in 3,377 deals compared to 3,408 deals traded previously.

TRANSCORP, ZENITHBANK, LASACO, UBA and ACCESS were the most active stocks by volume While ACCESS, UBA, ZENITHBANK, GUARANTY and MTNN top the activity chart by value. UAC-PROP, LINKASSURE, ROYALEX, WAPIC and VITAFOAM top the gainers table by gaining 8.33%, 7.69%, 6.45%, 6.06% and 5.09% while NEIMETH, AIICO, STERLNBANK, LASACO and TRANSCORP top the losers table by shedding 6.50%, 5.26%, 4.80%, 3.85% and 1.69%.
