

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.37% to settle the year to date return of the market at (-4.61%).

The Index closed at 25,605.64 basis point against the previous close of 25,511.02 basis point while Market Capitalization closed at 13,358,095,515,204.30 against previous close of 13,308,734,163,750.60. Volume traded increased by 80.56% from 232,416,080 to 419,659,630 while the total value of stocks traded increased by 187.98% from 1,315,221,250.27 to 3,787,582,931.80 in 4,152 deals compared to 3,377 deals traded previously.

LAWUNION, MANSARD, REDSTAREX, CHAMS and LASACO top the gainers table by gaining 9.71%, 9.58%, 6.58%, 4.76% and 4.00% while INITSPLC, WAPIC, NAHCO, MBENEFIT and CHAMPION top the losers table by shedding 9.52%, 5.71%, 4.76%, 4.55% and 3.23%.
