Dear Esteemed Investor.

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.28% to settle the year to date return of the market at (-5.28%).

The Index closed at 25,424.91 basis point against the previous close of 25,497.32 basis point while Market Capitalization closed at 13,263,809,309,331.10 against previous close of 13,301,583,426,360.60. Volume traded increased by 7.01% from 251,963,602 to 269,629,692 while the total value of stocks traded increased by 40.28% from 2,044,089,434.41 to 2,871,568,140.17 in 4,155 deals compared to 4,185 deals traded previously.

FIDSON, PZ, CUSTODIAN, FCMB and JOHNHOLT top the gainers table by gaining 7.28%, 6.25%, 3.13%, 2.73% and 1.82% while ROYALEX, LIVESTOCK, CILEASING, MBENEFIT and UACN top the losers table by shedding 10.00%, 9.09%, 8.97%, 4.76% and 4.76%.
