## Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.28% to settle the year to date return of the market at (-4.66%).

The Index closed at 25,591.95 basis point against the previous close of 25,520.97 basis point while Market Capitalization closed at 13,350,951,842,089.40 against previous close of 13,313,924,768,708.50. Volume traded decreased by 12.29% from 236,481,244 to 212,732,957 while the total value of stocks traded decreased by 42.62% from 1,647,629,237.22 to 2,278,217,683.05 in 3,239 deals compared to 3,251 deals traded previously.

NPFMCRFBK, UNIONDAC, ROYALEX, ETERNA and CORNERST top the gainers table by gaining 8.66%, 8.00%, 7.69%, 7.63% and 6.56% while ARDOVA, CAP, CHIPLC, JBERGER and REGALINS top the losers table by shedding 9.92%, 9.74%, 9.38%, 8.24% and 8.00%.
