

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.05% to settle the year to date return of the market at (-4.61%).

The Index closed at 25,605.59 basis point against the previous close of 25,591.95 basis point while Market Capitalization closed at 13,358,065,984,270.00 against previous close of 13,350,951,842,089.40. Volume traded increased by 20.82% from 212,732,957 to 257,027,926 while the total value of stocks traded increased by 45.73% from 2,278,217,683.05 to 3,320,061,769.91 in 3,567 deals compared to 3,239 deals traded previously.
