Dear Esteemed Investor.

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.03% to settle the year to date return of the market at (-4.63%).

The Index closed at 25,597.96 basis point against the previous close of 25,605.59 basis point while Market Capitalization closed at 13,354,088,167,445.30 against previous close of 13,358,065,984,270.00. Volume traded decreased by 4.63% from 257,027,926 to 245,139,497 while the total value of stocks traded decreased by 9.25% from 3,320,061,769.91 to 3,013,027,932.60 in 3,597 deals compared to 3,567 deals traded previously.

IKEJAHOTEL, UAC-PROP, CORNERST, JAPAULOIL and WAPCO top the gainers table by gaining 9.52%, 9.20%, 6.45%, 5.00% and 3.45% while NPFMCRFBK, UNIONDAC, REDSTAREX, NAHCO and OANDO top the losers table by shedding 9.42%, 7.41%, 6.13%, 6.10% and 5.46%.
