## Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.50% to settle the year to date return of the market at (-3.95%).

The Index closed at 25,783.02 basis point against the previous close of 25,654.90 basis point while Market Capitalization closed at 13,474,541,626,466.70 against previous close of 13,407,586,099,223.20. Volume traded increased by 58.05% from 262,046,333 to 414,161,428 while the total value of stocks traded increased by 42.74% from 4,399,605,300.80 to 6,280,160,136.63 in 3,793 deals compared to 3,254 deals traded previously.

INTBREW, PRESTIGE, CORNERST, UAC-PROP and SEPLAT top the gainers table by gaining 9.09%, 9.09%, 8.33%, 5.26% and 3.90% while ABCTRANS, ROYALEX, ETERNA, NPFMCRFBK and AllCO top the losers table by shedding 9.09%, 6.90%, 6.72%, 6.15% and 3.37%.
