Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 1.28% to settle the year to date return of the market at (-1.95%).

The Index closed at 26,319.34 basis point against the previous close of 25,987.14 basis point while Market Capitalization closed at 13,754,877,633,113.70 against previous close of 13,581,262,201,680.90. Volume traded decreased by 6.56% from 359,307,226 to 335,749,166 while the total value of stocks traded increased by 10.42% from 3,873,648,586.84 to 4,277,468,719.91 in 4,231 deals compared to 3,576 deals traded previously.

NB, CORNERST, ARDOVA, PRESCO and WAPCO top the gainers table by gaining 9.82%, 9.23%, 7.77%, 7.07% and 6.74% while NNFM, OANDO, UNIONDAC, ROYALEX and WAPIC top the losers table by shedding 10.00%, 9.78%, 7.41%, 6.90% and 5.56%.
