

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.72% to settle the year to date return of the market at (-1.25%).

The Index closed at 26,507.84 basis point against the previous close of 26,319.34 basis point while Market Capitalization closed at 13,853,388,065,088.40 against previous close of 13,754,877,633,113.70. Volume traded increased by 0.32% from 335,749,166 to 336,832,809 while the total value of stocks traded decreased by 5.80% from 4,277,468,719.91 to 4,029,276,076.42 in 4,602 deals compared to 4,231 deals traded previously.
