

Dear Esteemed Investor,

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.83% to settle the year to date return of the market at (-0.04%).

The Index closed at 26,831.76 basis point against the previous close of 26,611.96 basis point while Market Capitalization closed at 14,024,527,099,413.40 against previous close of 13,907,803,558,877.40. Volume traded decreased by 21.87% from 413,103,507 to 322,773,035 while the total value of stocks traded decreased by 10.80% from 4,527,905,823.93 to 4,039,015,932.71 in 4,046 deals compared to 4,681 deals traded previously.
