Dear Esteemed Investor.

The Nigerian equity market closed positive today as the All Share Index (ASI) gained 2.11% to settle the year to date return of the market at (2.65%).

The Index closed at 27,554.49 basis point against the previous close of 26,985.77 basis point while Market Capitalization closed at 14,402,282,255,343.50 against previous close of 14,105,025,278,205.90. Volume traded increased by 31.35% from 459,790,564 to 603,945,613 while the total value of stocks traded increased by 72.48% from 4,304,616,338.01 to 7,424,498,469.29 in 5,984 deals compared to 4,553 deals traded previously.

GLAXOSMITH, REDSTAREX, NPFMCRFBK, AFRIPRUD and WAPIC top the gainers table by gaining 10.00%, 10.00%, 9.60%, 9.47% and 8.33% while TRIPPLEG, OANDO, UAC-PROP, CHAMS and UBN top the losers table by shedding 10.00%, 8.73%, 6.52%, 4.76% and 2.00%.
