Dear Esteemed Investor.

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.95% to settle the year to date return of the market at (6.68%).

The Index closed at 28,634.35 basis point against the previous close of 28,909.37 basis point while Market Capitalization closed at 14,966,710,264,675.80 against previous close of 15,110,457,505,668.10. Volume traded increased by 11.13% from 749,467,693 to 832,879,354 while the total value of stocks traded increased by 0.46% from 9,495,221,631.65 to 9,539,161,242.52 in 9,180 deals compared to 8,075 deals traded previously.

BERGER, LINKASSURE, NASCON, MBENEFIT and CAP top the gainers table by gaining 9.84%, 9.76%, 9.59%, 9.52% and 9.36% while UNILEVER, CORNERST, ETI, UAC-PROP and CUSTODIAN top the losers table by shedding 9.89%, 9.09%, 8.89%, 8.14% and 7.21%.
