## Dear Esteemed Investor.

The Nigerian equity market closed negative today as the All Share Index (ASI) lost 0.31% to settle the year to date return of the market at (6.35%).

The Index closed at 28,546.22 basis point against the previous close of 28,634.35 basis point while Market Capitalization closed at 14,920,645,794,326.50 against previous close of 14,966,710,264,675.80. Volume traded decreased by 31.64% from 832,879,354 to 569,376,786 while the total value of stocks traded decreased by 48.49% from 9,539,161,242.52 to 4,913,512,627.93 in 6,101 deals compared to 9,180 deals traded previously.
