The Nigerian equity market closed positive today as the All Share Index (ASI) gained 0.02% to settle the year to date return of the market at (5.60%).

The Index closed at 28,344.04 basis point against the previous close of 28,337.49 basis point while Market Capitalization closed at 14,814,967,834,429.30 against previous close of 14,811,545,875,714.00. Volume traded increased by 45.14% from 369,177,675 to 535,831,943 while the total value of stocks traded decreased by 0.81% from 5,060,084,238.66 to 5,019,244,864.33 in 4,498 deals compared to 4,750 deals traded previously.
