The Nigerian equity market today ended in stalemate as the All Share Index remained unchanged to settle the year to date return of the market at (5.60%).

The Index closed at 28,344.04 basis point against the previous close of 28,344.33 basis point while Market Capitalization closed at 14,814,970,417,734.50 against previous close of 14,815,121,039,503.10. Volume traded increased by 56.66% from 218,424,964 to 342,193,352 while the total value of stocks traded increased by 60.55% from 3,138,929,472.46 to 5,039,651,504.77 in 4,048 deals compared to 3,896 deals traded previously.

ETERNA, WAPCO, GUINNESS, INTBREW and PZ top the gainers table by gaining 9.98%, 4.03%, 3.23%, 3.19% and 2.38% while AIICO, GLAXOSMITH, FIDSON, AFRIPRUD and GUARANTY top the losers table by shedding 3.57%, 3.45%, 3.00%, 2.81% and 1.67%.
