

Dear Esteemed Investor,

The Nigerian equity market today ended in stalemate as the All Share Index remained unchanged to settle the year to date return of the market at (6.77%).

The Index closed at 28,658.31 basis point against the previous close of 28,659.45 basis point while Market Capitalization closed at 14,979,231,093,954.50 against previous close of 14,979,830,022,541.60. Volume traded decreased by 41.26% from 489,111,123 to 287,300,067 while the total value of stocks traded decreased by 28.00% from 4,720,163,596.78 to 3,398,719,323.14 in 5,132 deals compared to 5,652 deals traded previously.
