The Nigerian equity market closed positive as the All Share Index gained 0.03% to settle the year to date return of the market at (6.79%).

The Index closed at 28,665.82 basis point against the previous close of 28,658.31 basis point while Market Capitalization closed at 14,983,157,268,577.50 against previous close of 14,979,231,093,954.50. Volume traded increased by 3.48% from 287,300,067 to 297,311,966 while the total value of stocks traded decreased by 13.88% from 3,398,719,323.14 to 2,926,878,117.39 in 4,736 deals compared to 5,132 deals traded previously.

INTBREW, UCAP, NB, FLOURMILL and ETERNA top the gainers table by gaining 9.90%, 8.17%, 4.67%, 4.55% and 4.48% while REGALINS, CORNERST, PZ, MOBIL and AllCO top the losers table by shedding 8.33%, 4.76%, 4.65%, 4.60% and 4.49%.
