Dear Esteemed Investor.

The Nigerian equity market closed negative as the All Share Index lost 0.75% to settle the year to date return of the market at (5.99%).

The Index closed at 28,449.49 basis point against the previous close of 28,665.82 basis point while Market Capitalization closed at 14,870,084,468,612.80 against previous close of 14,983,157,268,577.50. Volume traded increased by 9.84% from 297,311,966 to 326,577,644 while the total value of stocks traded increased by 44.34% from 2,926,878,117.39 to 4,224,774,200.28 in 4,367 deals compared to 4,736 deals traded previously.

WAPIC, PORTPAINT, UAC-PROP and NB are the only four gainers gaining 10.00%, 2.50%, 1.23% and 0.97% while ROYALEX, NEIMETH, UNIONDAC, LASACO and UCAP top the losers table by shedding 8.00%, 7.57%, 7.41%, 7.14% and 7.03%.
