

Dear Esteemed Investor,

The Nigerian equity market closed positive as the All Share Index gained 0.40% to settle the year to date return of the market at (6.41%).

The Index closed at 28,563.87 basis point against the previous close of 28,449.49 basis point while Market Capitalization closed at 14,929,868,775,080.30 against previous close of 14,870,084,468,612.80. Volume traded decreased by 4.67% from 326,577,644 to 311,333,143 while the total value of stocks traded increased by 11.04% from 4,224,774,200.28 to 4,691,198,861.38 in 3,375 deals compared to 4,367 deals traded previously.
