Dear Esteemed Investor.

The Nigerian equity market closed positive as the All Share Index gained 0.28% to settle the year to date return of the market at (7.21%).

The Index closed at 28,777.96 basis point against the previous close of 28,697.06 basis point while Market Capitalization closed at 15,041,770,167,831.20 against previous close of 14,999,485,393,585.20. Volume traded increased by 20.44% from 282,970,739 to 340,804,399 while the total value of stocks traded increased by 25.63% from 4,426,532,716.56 to 5,560,887,612.58 in 4,235 deals compared to 2,942 deals traded previously.

CUSTODIAN, NPFMCRFBK, ETRANZACT, ETI and LASACO top the gainers table by gaining 10.00%, 9.70%, 7.73%, 7.69% and 7.69% while MORISON, CHIPLC, NASCON, WAPIC and LIVESTOCK top the losers table by shedding 10.00%, 8.82%, 8.39%, 7.50% and 7.46%.
