## Dear Esteemed Investor.

The Nigerian equity market closed positive as the All Share Index gained 1.58% to settle the year to date return of the market at (9.67%).

The Index closed at 29,437.60 basis point against the previous close of 28,980.29 basis point while Market Capitalization closed at 15,386,554,730,266.00 against previous close of 15,147,528,546,420.80. Volume traded decreased by 2.68% from 385,598,796 to 375,249,909 while the total value of stocks traded increased by 59.02% from 2,914,255,653,39 to 4,634,120,008,94 in 5,947 deals compared to 5,283 deals traded previously.
