

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All Share Index lost 0.17% to settle the year to date return of the market at (13.55%).

The Index closed at 30,479.39 basis point against the previous close of 30,530.69 basis point while Market Capitalization closed at 15,931,082,521,376.80 against previous close of 15,957,896,854,477.70. Volume traded decreased by 53.37% from 807,810,817 to 376,653,389 while the total value of stocks traded decreased by 63.79% from 10,501,022,806.24 to 3,802,138,741.59 in 6,050 deals compared to 8,113 deals traded previously.

LIVESTOCK, DANGSUGAR, NPFMCRFBK, REGALINS and ROYALEX top the gainers table by gaining 9.88%, 9.78%, 9.68%, 9.09% and 8.70% while CILEASING, FCMB, ETI, OANDO and INTBREW top the losers table by shedding 10.00%, 9.90%, 8.85%, 6.55% and 5.02%.
